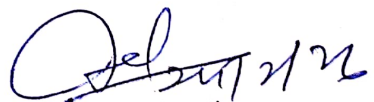

With reference to your application on the subject cited above, I am directed to convey the approval of the Competent Authority i.e., Director (Education) vide U.O. No. 242/DE dated 30.01.2026 for grant of Extension of Provisional Recognition of school from Pre-School to Secondary Level for a period of ten years w.e.f. 01.04.2025 to 31.03.2035 (without Aid) and Provisional Up-Gradation upto Sr. Secondary Level (Arts & Commerce Streams) with one section for each class under DSEAR 1973 for a period of five years w.e.f. 01.04.2025 to 31.03.2030 (without Aid) in r/o KAMS Convent School (ID:-1309282), 122 Main Road, Kushiak No. 2, Kadipur Delhi-110036 subject to following terms & conditions:-

1. Final outcome of the notification of MoUD, Govt. of India.
2. That the school shall observe the relevant provisions of DSEAR 1973 & RTE Act, 2009 and directions/instructions issued by the Department from time to time.
3. That the school shall comply with the orders dated 07.11.2017/guidelines of DoE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
4. That the School shall comply with clause 14 of order No.F.DE/15(56)/ACT/2009/778 dated 11.02.2009 in r/o maintenance of DRF. School shall also follow FN-21 'Accounting by schools' as issued by the institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
5. That the school shall provide facilities under Section 10(1) of DSEAR 1973 the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through Bank/RTGS and submit the compliance report within 02 months to the district authority.
6. That the school shall comply with the order F.No.DE.15(305)/PSB/Misc./2020/P1.File-11/5658-5662 dated 21.06.2023 with regard to appointment of Special Educator.
7. That the school shall comply with No.DE.15(305)/PSB/2020/Pt.File-1/5641-5647 order the dated 20.06.2023 regarding submission of renewed/updated certificates like Fire NOC, Water Test Report, School Health Certificate, School Building Certificate/Structural Stability Certificate to the zonal authorities of DoE.
8. That the school shall comply with the provisions of Rules 176, 177, 18(5), 17(3) & order dated 15.12.1999, 10.02.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.
9. That the school shall comply regarding submission of annual return u/r 180(1) of DSEAR 1973 for the financial year 2024-25 within two months to the District/Zonal Authority.
10. Further, the proposal for granting recognition subject to the condition that "Nothing contained in the grant of provisional recognition to the school shall be deemed to affect or determine the ownership or title or status of the land".
11. The School Authority shall appoint adequate staff (Teaching or non-teaching) as per the existing RR of the post.

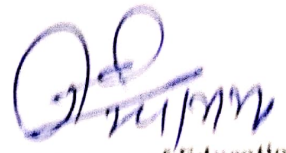
